

## MAKEUP BEFORE YOU WAKEUP

### Disclosures and liabilities form

1) We are a tattoo shop. As with all tattoo shops, once the work is done, your lifestyle, personal genetics and aftercare determine how the ink will settle and hold. We do not take responsibility for the outcome of your tattoo once you leave, as we have no control over the above factors. No tattoo shop would ever assume responsibility for how their client's skin processes the color, or the ink and nor can we. Our work is not guaranteed outside of our office. You must understand that many factors outside of our office contribute to how long your tattoo stays, how the color translates, how firm the hairstrokes, or the shape stays and how often you need a touch up. If you need further work, you have the option to book as many touch ups as you need online, no sooner than 2 months between appointments but this will be at your discretion and the fees will be covered by you. We cannot tattoo you any sooner than 4 weeks once you walk out of the shop. You agree to this and understand this. X \_\_\_\_\_

2) You will not message us, or send photos regarding the healing of the tattoo between the first appointment and the touch up. It has been fully disclosed to you that the tattoo will shed and will change between the primary appointment and the touch up. If you accidentally damage the brow, we can take care of it at the touch up. If you see things that bother you on shape, size or color, please wait until the touch up for these things to be fixed. If your brows are peeling, they will settle out and anything that doesn't rerise will be addressed at the touch up. You must wait for the process to complete. Everyone goes through a panic phase during the shedding. You will be okay and all your worries will be addressed at your touch up. If it is an emergency, please contact 911. I have read and understood this

and agree to wait until my touch up to address concerns.

3) You must have your first touch no later than 3 months to not incur additional fees to receive a touch up. If you wait longer than 12 months to have a touch up from another procedure, you will need to schedule a full appointment. I have read and understood and agree to this. X \_\_\_\_\_

4) For Microblading, hair strokes on some clients stay and on other clients blend. Factors such as: oily skin, anemia, diabetes, alcoholism, unhealthy skin, thin skin, sun damaged skin, medication and topical creams affect this. Please avoid skin lighteners, sun and aloe vera. We have no control over how your skin holds the template, or the hair strokes, especially epidermal tattoos. I have read and understood and agree to this. X \_\_\_\_\_

5) We do not give refunds on our work. You will approve the template and allow us to proceed. Factors such as: anemia, poor skin, oily skin, cancerous skin, medications, thin skin, diabetes and alcoholism affect the outcome of the tattoo. I have read and understood this and agree to it. X \_\_\_\_\_

6) We do not go over anyone's work, even after we do your brows the first time. It is a liability and can cause whitewashing in brows because of the mix of pigments. You will need to start over should you choose to switch providers. I have read and understood and agree to this. X \_\_\_\_\_

7) We have the right to refuse service to anyone, at any time. We will discontinue service on anyone who does not follow policy, threatens us, harrasses us, or is disrespectful. Even after a primary procedure, we have the right to refuse on a touch up if the client does not respect our policies. I have read and understood this and agree to this. X \_\_\_\_\_

8) How long before I need another touch up? This is something we cannot predict. Lifestyle, aftercare and genetics all contribute

to your brow life and longevity. Microblading is a semi-permanent tattoo and additional types of tattooing can change as well over time. I have read and understood and agree to this. X \_\_\_\_\_

9) I have looked over my tattoo and am satisfied with the results of my appointment. X \_\_\_\_\_

10) I release all rights of photography to the company and understand that the photos are necessary for keeping track of my progress. X \_\_\_\_\_

I have represented myself in a stable frame of mind and agree to the ten points above and understand that any retaliation against the company, through public reviews or defamation will result in legal action against me, due to the fact that full disclosure was made before procedure and that the client signed off on them and agreed to them. Client will be responsible for all legal fees needed to defend the reputation on this company in said case.
